请在登入账户后，点击“我的账户” > “存款 / 转户” > “资产转移” 来开始进行转户。

若您以表格方式进行转户，请按照以下说明来填写账户转移表格：

第一部份：Information about your account (您的第一证券账户资料)：请填写第一证券账户资料。

第二部份：Information about the account you are transferring (对方公司账户资料)

第三部份：Type of Transfer (转户类型)：请选择适用之转户类型（共 8 种选项）。

- Brokerage Firm Transfer (Transfer all assets in kind) 直接从证券公司转入 (实物证券的转移, 包括账户持有的全部证券以及现金)。
- Liquidate all assets and Transfer as cash 出售全部持有资产/证券, 以现金转入。

第四部份：Partial Transfer(部份资产转移)：若您只要转入部份资产，请列出所有您想要转入的资产并选择“Transfer in Kind 实物证券的转移”或者“Liquidate 出售”（卖出该项资产 / 证券，以现金形式转入）。

第五部份：Mutual Fund Company Transfer (共同基金公司转户)：若您是从共同基金公司转入，请填写此部份。

第六部份：Signature(s) (签名)：所有账户持有人都必须签名。若您是对方公司账户的监护人或受托人，请填写并签署此部份。

第七部份：Letter of Authorization (授权书)：若您是从对方公司的个人账户转入第一证券的联名账户，请填写此部份。（签名处需要公证）
