

Account Transfer Form 賬戶轉移表格

您知道您可以進行線上一鍵轉戶嗎?

請準備以下資料:

- 對方公司名稱及賬戶號碼
- 同類型賬戶 您在對方公司現有的賬戶類型必須與您的第一證券賬戶一致

請在登入賬戶後,點擊"我的賬戶">"存款/轉戶">"資產轉移"來開始進行轉戶。

若您以表格方式進行轉戶,請按照以下說明來填寫賬戶轉移表格:

第一部份: Information about your account (您的第一證券賬戶資料): 請填寫第一證券賬戶資料。

第二部份:Information about the account you are transferring (對方公司賬戶資料)

第三部份: Type of Transfer (轉戶類型): 請選擇適用之轉戶類型 (共 8 種選項)。

- Brokerage Firm Transfer (Transfer all assets in kind) 直接從證券公司轉入 (實物證券的轉移, 包括賬戶內持有的全部證券以及現金)。
- Liquidate all assets and Transfer as cash 出售全部持有資產/證券, 以現金轉入。
- Partial Transfer (skip to Section 4) 部分資產轉移 (請填第4 部份) 。
- Mutual Fund Company Transfer (skip to Section 5) 共同基金公司轉移 (請填第5部份) 。
- Non-ACAT Transfer (Transfer all assets in kind) 非ACAT 轉移 (實物證券的轉移, 包括賬戶內持有的全部證券以及現金)。
- Liquidate annuity and transfer as cash. 出售全部持有年金, 以現金轉入。
- Liquidate Certifications of Deposit IMMEDIATELY. (I am aware of and acknowledge the penalty for early withdrawal) 立即出售定期存款(我知道並確認提前支取未到期的定存會產生罰款)。
- Transfer proceeds to Certificate of Deposit AT MATURITY (submit transfer request 30 days prior to maturity) 在 定期存款到期日轉移(需在到期日前 30 天遞交轉移申請)。

第四部份:Partial Transfer(部份資產轉移): 若您只要轉入部份資產·請列出所有您想要轉入的資產並選擇"Transfer in Kind 實物證券的轉移"或者"Liquidate 出售"(賣出該項資產/證券‧以現金形式轉入)。

<mark>第五部份:Mutual Fund Company Transfer (共同基金公司轉戶):</mark> 若您是從共同基金公司轉入·請填寫此部份。

第六部份: Signature(s) (簽名): 所有賬戶持有人都必須簽名。若您是對方公司賬戶的監護人或受託人,請填寫並簽署此部份。

第七部份:Letter of Authorization (授權書): 若您是從對方公司的個人賬戶轉入第一證券的聯名賬戶·請填寫此部份。(簽名處需要公證)
